- Law Student Recognition: Nominations Accepted : All students, faculty, and staff may submit nominations, only 3L students are eligible to receive these awards. Nominations, in the form of a one-page statement concerning the nominee and designating the award(s) for which the student is being nominated, are due to the Dean of Students, law.dos@cornell.edu, by December 3rd.
 - 1) The Freeman Award for Civil-Human Rights: students who have made the greatest contribution during their law school career to civil-human rights.
 - 2) The Stanley E. Gould Prize for Public Interest Law: third-year student or students who have shown outstanding dedication to serving public-interest law and public-interest groups.
 - 3) The Seymour Herzog Memorial Prize: students who demonstrate excellence in the law and commitment to public-interest law, combined with a love of sports.
